SCOPE OF WORKS

Provide all qualified personnel, materials, equipment, tools, and services required to perform the plumbing works at NMC and Network location to an acceptable standard, in accordance to best industry practices and the Water and Sewerage Authority Standard.

Plumbing and Mechanical System

a). Wastewater System

i. General

The contractor will undertake to maintain and keep in good order, all sewers, wastewater pipes and supports, vent pipes and traps. Manholes will be kept clean and grease trap will be periodically cleared.

All clogs occurring in the lines will be cleared as quickly as possible and preventative measures will be taken to avoid any occurrences.

A Preventative Maintenance System will be established and implemented to minimize disruptions at the facility and any inconveniences to the users of the facility.
